

## **RESOLUTION NO. 2016-128**

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF PEORIA, ARIZONA, AUTHORIZING CERTAIN ADJUSTMENTS TO THE RATES IMPOSED FOR USE OF THE PUBLIC WATER TREATMENT SYSTEM; SYSTEM RATE COMPONENTS; SERVICE CHARGES AND FEES FOR USE OF THE MUNICIPAL WATER UTILITY SYSTEM AND REVISING A SCHEDULE OF CHARGES FOR THE USE OF THE MUNICIPAL WATER SYSTEM AND ALL SUCH ADJUSTMENTS TO BECOME EFFECTIVE AS PROVIDED HEREIN AND PROVIDING FOR AN EFFECTIVE DATE.

### RECITALS

The Mayor and Council of the City of Peoria, Arizona, find and determine as follows:

1. The City incorporated the water users of the New River Utility Company on November 6, 2015; and
2. The City agreed to maintain the water user rates and charges of the New River Utility Company until a date specific, at which time, the City would implement existing City water rates and charges; and
3. The City adopted existing water rates and charges pursuant to A.R.S. §9-511.01; and
4. The City will implement the existing schedule of water rates and charges for the water users of the former New River Utility Company service area.

THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Peoria, Arizona, as follows:

Section 1. Effective January 1, 2017 monthly water user charges, rate components, service charges and fees provided in the attached schedule (Exhibit A), and applicable to

the water users of the former New River Utility Company, shall no longer be valid.

Section 2. That the Chief Financial Officer is hereby authorized to implement the current water user charges, rate components and fees in the existing City code on the water users of the former New River Utility Company.

Section 3. That all other rates presently being charged are hereby affirmed and will remain in effect until changed by the City Council.

Section 4. This Resolution shall become effective in the manner provided by law.
