AMENDMENT TWO

TO

**INTERGOVERNMENTAL AGREEMENT
BETWEEN
MARICOPA COUNTY
AND
THE CITY OF PEORIA
(C-30-08-036-5-02)**

THIS Amendment Two (“Amendment”) to Intergovernmental Agreement entered into between Maricopa County, a political subdivision of the State of Arizona, hereinafter referred to as the “County,” and the City of Peoria, a political subdivision of the State of Arizona, and hereinafter referred to as the “City.” The County and City are sometimes hereinafter referred to collectively as the “Parties” or individually as a “Party.”

WHEREAS, an Intergovernmental Agreement (“Agreement”) was entered into between the County and the City on August 8, 2008 (C-30-08-036-5-00) that established a partnership between the County and City to construct a multi-modal trail section as an alternative transportation route through the west valley communities from White Tank Mountain Regional Park to Lake Pleasant Regional Park; and

WHEREAS, Amendment One to Intergovernmental Agreement (C-30-08-036-5-01) dated June 24, 2016, clarified certain administrative provisions of the Agreement and provided a route for the multi-modal trail section as Exhibit 1 to the Agreement; and

WHEREAS, the County and City now desire and agree to add responsibilities for trail signage maintenance to the amended Agreement; and

WHEREAS, County and City now desire to enter into this Amendment Two, with the understanding that, unless specifically changed hereby, all other provisions of the Agreement shall remain in full force and effect.

NOW, THEREFORE, in consideration of the foregoing recitals, which are incorporated herein, and with other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. **Project Description**

Section 3. Responsibilities of the Agreement is deleted in its entirety and replaced with the following:

3. **RESPONSIBILITIES**

- A. It is agreed that the Maricopa County Parks and Recreation Department will:
 - i. Provide signage designating the Trail Segment as the Maricopa Trail.
 - ii. Be responsible for the maintenance and installation of its signs on the Trail Segment through the CITY.
 - iii. Partner with and/or support the CITY in future efforts to secure funding for improvements to the Trail Segment, if feasible and approved.
- B. It is agreed that the City will:
 - i. Maintain the Trail Segment to City Trail standards, including any improvements to the surfacing of the Trail.
 - ii. Assure that the Trail Segment will remain as part of the CITY'S Trail System.
 - iii. Authorize co-located trail designation and wayfinding signage on existing sign infrastructure, where appropriate and upon review by CITY.

2. **Effective Date**

The effective date of this Amendment is the date of execution by the Chairman of the Maricopa County Board of Supervisors.

3. **Remaining Terms of the Agreement**

The foregoing paragraphs contain all the changes made by this Amendment Two. All other terms and conditions of the Agreement and Amendment One shall remain unchanged and in full force and effect.
