

RESOLUTION NO. 2024-63

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF PEORIA, MARICOPA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE MARICOPA COUNTY AND YAVAPAI COUNTY PRIMARY ELECTION HELD ON JULY 30, 2024.

WHEREAS, the City of Peoria, Maricopa County, Arizona held a Primary Election on the 30<sup>th</sup> day of July 2024 for the nomination of a Mesquite District Councilmember, and

WHEREAS the election returns have been presented to and have been canvassed by the Maricopa County Board of Supervisors on August 12, 2024, and hereby canvassed by the Peoria City Council pursuant to Arizona Revised Statutes §§ 16-642 and 16-646.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the City of Peoria, Maricopa County, Arizona, declare the results of the Primary Election, as follows:

SECTION 1. That the total number of ballots cast at said Primary Election, as reported on Exhibit A - Maricopa County Elections Department Final Official Report was 9,116 and Exhibit B - Yavapai County Elections Department was 0.

SECTION 2. That the total votes cast at said Primary, for the office of Councilmember in the Mesquite District were as follows:

SECTION 3: That it is hereby found, determined, and declared of record that the following candidate did, pursuant to Peoria City Code-Chapter 4, Section 4.1(b), receive more than one-half of the total number of ballots cast for the office sought and are hereby issued a certificate of election, with a term of office commencing on the first scheduled meeting of January 2025 and for a period of four (4) years or until a successor is elected and qualified:
