

**AMENDMENT TO  
THE INTERGOVERNMENTAL AGREEMENT  
BETWEEN THE CITY OF PEORIA AND THE PEORIA UNIFIED SCHOOL DISTRICT  
FOR SCHOOL RESOURCE OFFICERS AND SCHOOL LIAISON OFFICERS**

THIS AMENDMENT to the Intergovernmental Agreement for School Resource Officers AND School Liaison Officers dated May 12, 2022 is made this 29<sup>th</sup> day of May, 2025, by and between the City of Peoria, Arizona, an Arizona Charter City and municipal corporation referred to as "Peoria" and the Peoria Unified School District, a political subdivision of the State of Arizona (the "District"). Peoria and the District are collectively referred to as "Parties".

**RECITALS**

WHEREAS, the Parties entered into an Intergovernmental Agreement for School Resource Officers dated May 12, 2022 ("Agreement") that set forth the terms and conditions of Peoria providing the District with School Resource Officers; and

WHEREAS, the Parties previously entered into an Amended Agreement dated June 8, 2023, whereby additional School Resource Officers and School Liaison Officers were added and the term of the Agreement was confirmed to extend through May 31, 2025; and

WHEREAS, the Amended Agreement will terminate on May 31, 2025; and

WHEREAS, the Amended Agreement only may be extended or modified in writing signed by the Parties; and

WHEREAS, the Parties desire to extend the term of the Amended Agreement for one year through May 31, 2026.

In consideration of the mutual benefits and obligations set forth in this Amendment, the Parties agree as follows:

**I. EXTENSION OF TERM**

Paragraphs 1 and 2 of the Amended Agreement shall be amended to extend the termination date of the Amended Agreement through May 31, 2026.

**II. NO OTHER CHANGES**

Except for the amendment set forth in Section I herein which extends the termination date of the Amended Agreement through May 31, 2026, and provides the Parties with the opportunity to mutually agree to a limited further extension, all other terms and conditions of the Amended Agreement shall remain in full force and effect.

IN WITNESS WHEREOF, the Parties have executed this Amendment to the Amended Agreement effective as of the date first set forth above.
