RESOLUTION NO. 2025-90

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF PEORIA, MARICOPA COUNTY, ARIZONA AMENDING FIGURE 5 CIRCULATION MAP WITHIN THE INTEGRATED TRANSPORTATION CHAPTER OF THE PEORIA GENERAL PLAN FOR THE CITY OF PEORIA, ARIZONA; AND PROVIDING FOR SEPARABILITY AND AN EFFECTIVE DATE.

WHEREAS, the General Plan heretofore adopted by the City of Peoria, Arizona provides for periodic review and amendment;

WHEREAS, the City of Peoria is required to follow the procedures of A.R.S. 9-461.06 in adopting any amendments to the General Plan; and

WHEREAS, the Peoria Planning and Zoning Commission, after due and proper notice as required by law, held public hearings regarding minor general plan amendment number GPA25-02, on August 7, 2025; and

WHEREAS, after such public hearing and consideration of GPA25-02, the Peoria Planning and Zoning Commission recommended adoption of GPA25-02 on August 7, 2025, a copy of which recommendation is on file with the City Clerk of the City of Peoria, Arizona, and which said case number GPA25-02 was transmitted to the Mayor and Council of the City of Peoria prior to the meeting of August 26, 2025; and

WHEREAS, after notice in the manner and form provided by law, a public hearing regarding case number GPA25-02 was held by the City Council on August 26, 2025, as required by A.R.S. 9-461.06; and

WHEREAS, after due and proper consideration of such GPA25-02, the Mayor and Council of the City of Peoria, Arizona, have found that GPA25-02 will properly aid in the orderly growth and development of the City of Peoria, Arizona.

NOW, THEREFORE be it resolved by the mayor and council of the City of Peoria, Arizona as follows:

SECTION 1. Amendments to the Peoria General Plan

The City Council of the City of Peoria, Arizona, does hereby accept and adopt amendment number GPA25-02 amending Figure 5 Circulation Map within the Integrated Transportation Chapter of the Peoria General Plan, which is on file with the Peoria Planning Department.

SECTION 2. Separability.

In the event any part, portion or paragraph of this Resolution is found to be invalid by any court of competent jurisdiction, the invalidity of such part, portion, or paragraph shall not affect any other valid part, portion, or paragraph of this Resolution and effectiveness thereof;

SECTION 3. Effective Date

This Resolution shall become effective in the manner provided by law.
