

RESOLUTION NO. 2026-21

RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF PEORIA, ARIZONA DECLARING ITS INTENTION TO ORDER THE PURCHASE OF ELECTRICITY FOR LIGHTING THE STREETS AND PUBLIC PARKS WITHIN THE PROPOSED DISTRICT AND THAT THE COST OF THE PURCHASE OF ELECTRICITY FOR LIGHTING THE STREETS AND PUBLIC PARKS, BE ASSESSED UPON A CERTAIN IMPROVEMENT DISTRICT TO BE KNOWN AS CITY OF PEORIA STREETLIGHT IMPROVEMENT DISTRICT NO. 1196, VISTANCIA PARCEL J-18; PROVIDING THAT THE COST OF THE ELECTRICITY REQUIRED TO OPERATE THE SYSTEM BE ASSESSED UNDER THE PROVISIONS OF TITLE 48, CHAPTER 4, ARTICLE 2, ARIZONA REVISED STATUTES, AS AMENDED; AND DECLARING AN EMERGENCY.

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF PEORIA, ARIZONA, THAT:

SECTION 1. The public interest or convenience require and it is the intention of the Mayor and Council of the City of Peoria, Arizona to order the purchase of electricity for lighting the streets and public parks within the proposed district.

The estimate of the cost and expenses for the purchase of electricity for the operation of the streetlights on file with the Superintendent of Streets and the City Clerk is approved and adopted by the Mayor and Council of the City.

SECTION 2. The streetlights and the electricity, therefore, in the opinion of the Mayor and Council of the City, are of more than local or ordinary public benefit, and are of special benefit to the respective lots, pieces and parcels of land within the real property described herein. The Mayor and Council of the City make and order that the cost and expense for the purchase of electricity be

chargeable upon a district to be known and designated as the City of Peoria Streetlight Improvement District No. 1196 and as described and bounded as set forth on Exhibits A and B attached, and declare that the district in the City benefited by the purchase of electricity for streetlights to be assessed, to pay the costs and expenses thereof in proportion to the benefits derived therefrom.

The City shall not assess the costs and expenses for the purchase of electricity for streetlights which are for the general public benefit against the respective lots, pieces and parcels of land located within the boundaries of the City of Peoria Streetlight Improvement District No. 1196 and if a portion of the costs and expenses for the purchase of electricity for streetlights is for the general public benefit, the City shall assess the boundaries of the City of Peoria Streetlight Improvement District No. 1196 only that portion of such costs and expenses which benefits the lots, pieces and parcels of land located within the boundaries of the City of Peoria Streetlight Improvement District No. 1196.

SECTION 3. The costs and expense for the purchase of electricity for streetlights shall be made and all proceedings therein taken; that the Superintendent of Streets of the City shall post or cause to be posted notices thereof; that the City Clerk shall certify to the passage of this Resolution of Intention; that the Engineer shall prepare duplicate diagrams of the City of Peoria Streetlight Improvement District No. 1196 described in Section 2 of this Resolution to be assessed to pay the costs and expenses thereof, under and in accordance with the provisions of Title 48, Chapter 4, Article 2, Arizona Revised Statutes, as amended.

SECTION 4. The majority of owners of all of the real property within the proposed district have executed a Petition for formation of a Streetlight Improvement District and the City Council has verified the ownership of the property. Publication and posting of the notice of the passage of the Resolution of Intention will be completed as prescribed by the State Statutes.

SECTION 5. Any Resolutions or parts of Resolutions in conflict with the provisions of this Resolution are hereby repealed.

SECTION 6. The immediate operation of the provisions of this Resolution is necessary for the preservation of the public peace, health and safety and an emergency is declared to exist, and this Resolution will be in full force and effect from and after its passage and approval by the Mayor and Council of the City of Peoria, Arizona as required by law and is exempt from the referendum provisions of the Constitution and laws of the State of Arizona.

LEGAL DESCRIPTION
STREET LIGHT IMPROVEMENT DISTRICT No. 1196
"VILLAGE J AT VISTANCIA, PARCEL J-18"

All that certain lot, tract, or parcel of land, situated in a portion of the West Half of Section 11, Township 5 North, Range 1 West of the Gila and Salt River Base and Meridian, Maricopa County, Arizona, and being more completely described as follows, to-wit:

COMMENCING at a found GLO cap on a 2" iron pipe stamped "1922 S. 1, 2, 11, 12" for the Northeast corner of said Section 11, from which a found GLO cap on a 1" iron pipe stamped "1922 S. 2, 11-1/4" for a witness corner of the North Quarter corner of said Section 11 bears North 89 deg. 41 min. 55 sec. West – 2,620.99 feet;

THENCE South 00 deg. 12 min. 34 sec. West (Basis of Bearings) along the East line of the Northeast Quarter of said Section 11, a distance of 1,379.78 feet, from which a found GLO cap on a 3/4" iron pipe stamped "1922 S. 11, 12-1/4" for the East Quarter corner of said Section 11 bears South 00 deg. 12 min. 34 sec. West – 1,258.43 feet;

THENCE North 89 deg. 47 min. 26 sec. West departing said East line, a distance of 3,328.55 feet, said point being the **TRUE POINT OF BEGINNING**;

THENCE South 25 deg. 41 min. 37 sec. East, a distance of 108.03 feet;

THENCE South 00 deg. 00 min. 00 sec. East, a distance of 557.70 feet;

THENCE South 29 deg. 55 min. 18 sec. East, a distance of 212.51 feet;

THENCE South 04 deg. 55 min. 57 sec. West, a distance of 201.44 feet;

THENCE South 22 deg. 12 min. 25 sec. East, a distance of 96.47 feet;

THENCE South 68 deg. 44 min. 24 sec. East, a distance of 88.75 feet;

THENCE South 21 deg. 15 min. 36 sec. West, a distance of 237.90 feet;

THENCE North 68 deg. 44 min. 24 sec. West, a distance of 35.00 feet;
