Purpose:

Discussion and possible action to adopt **RES. 2022-128** approving the official Canvass of Election for the November 8, 2022, City of Peoria Regular and Special Elections.

A Certificate of Election for the Mesquite District Special Election will be presented following the vote. (Framed certificates will be presented when all the elected candidates take office in January 2023.)

Summary:

Pursuant to Arizona Revised Statutes § 16-642, City Council must meet and canvass the Regular and Special Elections held November 8, 2022. The canvass is the act that declares the election results official. State Statute requires the canvass to be completed not less than six days and not more than twenty days following the election. The deadline for this action is November 28, 2022.

Previous Actions/Background:

On March 1, 2022, City Council directed the City Clerk to publish the Call and Notice of Election for a citywide Primary Election on August 2, 2022 and if necessary, a General Election on November 8, 2022. The Council authorized the City Clerk and City Attorney to take actions necessary to conduct the elections.

On April 19, 2022, City Council directed the City Clerk to publish the Call and Notice of Election for a Mesquite District Special Primary Election held on November 8, 2022, and if necessary, a Special Runoff General Election held on March 13, 2023.

In 2020 Peoria voters approved a revision to City Charter, Article IV, Section 6 that if no more than two (2) candidates file nomination petitions for an office, the Primary Election can be dispensed with. No more than two candidates filed nomination petitions for the offices of Mayor and Councilmembers for the Acacia, Mesquite, Palo Verde and Pine Districts for the 2022 Elections and as such, a Primary Election for these offices was not held in accordance with City

Charter.

On November 8, 2022, a General Election was conducted for the offices of Mayor and Councilmember for the Acacia, Palo Verde, and Pine Districts. Additionally, on November 8, 2022, a Special Election was conducted for the Councilmember for the Mesquite District.

Options:

Adopt **Resolution No. 2022-128** approving the Canvass of Election for the November 8, 2022, Regular and Special Elections.

Staff Recommendation:

Staff recommends the adoption of Resolution No. 2022-128 approving the Canvass of Election for the November 8, 2022, Regular General and Special Primary Elections.

Fiscal Analysis:

There is no anticipated budget impact for adopting the Canvass of Election.

RESOLUTION NO. 2022-128

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF PEORIA, MARICOPA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE MARICOPA COUNTY AND YAVAPAI COUNTY REGULAR AND SPECIAL GENERAL ELECTIONS HELD ON NOVEMBER 8, 2022

WHEREAS, the City of Peoria, Maricopa County, Arizona did issue a Call and Notice on March 1, 2022 for a Regular Primary Election, and if necessary, a Regular General Election; and did cause to be submitted to the qualified electors for the election of Mayor and the Councilmember for the Acacia, Palo Verde and Pine Districts;

WHEREAS, the City of Peoria, Maricopa County, Arizona did issue a Call and Notice on April 19, 2022 for a Special Primary Election, and if necessary, a Special General Election; and did cause to be submitted to the qualified electors for the election of the Councilmember for the Mesquite District; and

WHEREAS, a portion of the Mesquite District of the City of Peoria is located in both Maricopa and Yavapai Counties and ballots were prepared for both counties; and

WHEREAS, the City of Peoria Charter, Article IX, Section 6, provides that if no more than two candidates file nominating petitions for each vacancy in office, the Primary Election shall be dispensed with as to that office; and

WHEREAS, the City of Peoria Regular Primary and Special Primary Elections were dispensed with as no more than two candidates filed nominating petitions for the offices of Mayor and Councilmember in the Acacia, Mesquite, Palo Verde and Pine Districts; and

WHEREAS, the City of Peoria, Maricopa County, Arizona did hold a Regular General Election and a Special General Election on November 8, 2022; and

WHEREAS, the election returns have been presented to and hereby canvassed by the City Council.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Peoria, Maricopa County, Arizona, as follows:

SECTION 1. That the total number of ballots cast and total voter turnout at said Regular and Special General Elections, as shown by the final results as reported by Maricopa and Yavapai Counties, is set forth on Exhibit “A” – Summary Report, attached and incorporated to this resolution.

SECTION 2. That the number of votes cast at each precinct at said Regular and Special General Elections, as shown by the final results as reported by Maricopa and Yavapai Counties, is set forth on Exhibit “B” – Precinct Canvass, attached and incorporated to this resolution.

SECTION 3. That the number of provisional ballots, the total number of provisional ballots tabulated, and the total number of provisional ballots found to be invalid and not counted at said Regular and Special General Elections, as shown by the final results as reported by Maricopa and Yavapai Counties, is set forth on Exhibit “C” – Provisional Ballots, attached and incorporated to this resolution.

SECTION 4. That the number of rejected ballots by precinct at said Regular and Special General Elections, as shown by the final results as reported by Maricopa and Yavapai Counties, is set forth on Exhibit “D” – Rejected Ballots by Precinct, attached and incorporated to this resolution.

SECTION 5. That the total number of votes cast at said Regular General Election, for the office of Mayor are as follows:
